# GLOBAL HARMONIZED SYSTEM (GHS) COMPLIANCE

All Indium Corporation products that are shipped from our facilities have required GHS labels and Safety Data Sheets (SDS) that are compliant with the destination's local regulations. GHS is a United Nations (UN) agreed-upon standard that originated in 1992. Although a country's adoption is not mandatory, most countries in Europe, the Americas, and Asia have adopted the standard as part of their internal health and safety requirements. The schedule for adoption varies by country.

Note that, even though the global health and safety bodies, such as the USA's OSHA, have adopted the UN GHS, the standard does not supersede or obsolete any US, local, or international environmental and transportation (shipping) requirements.
